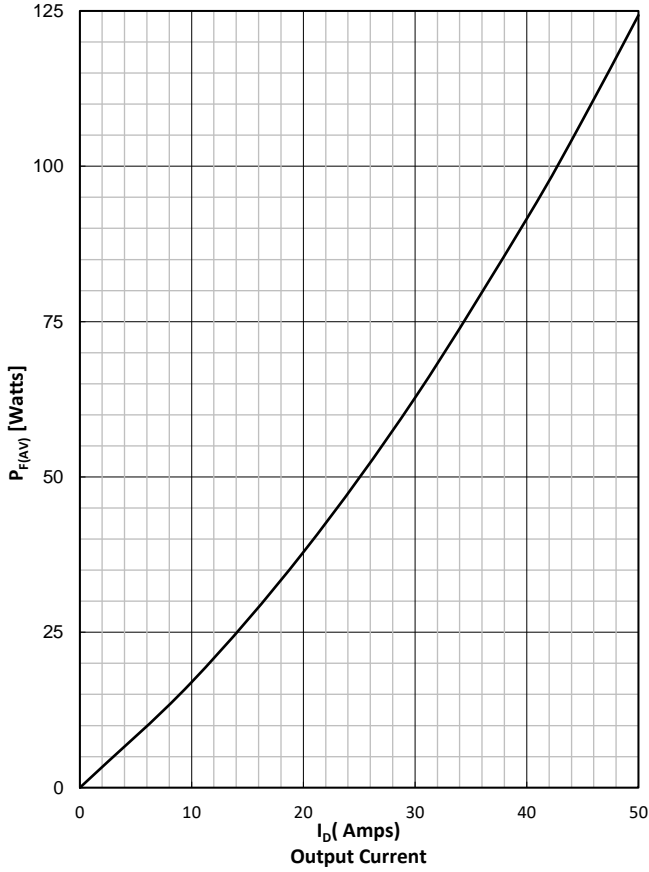

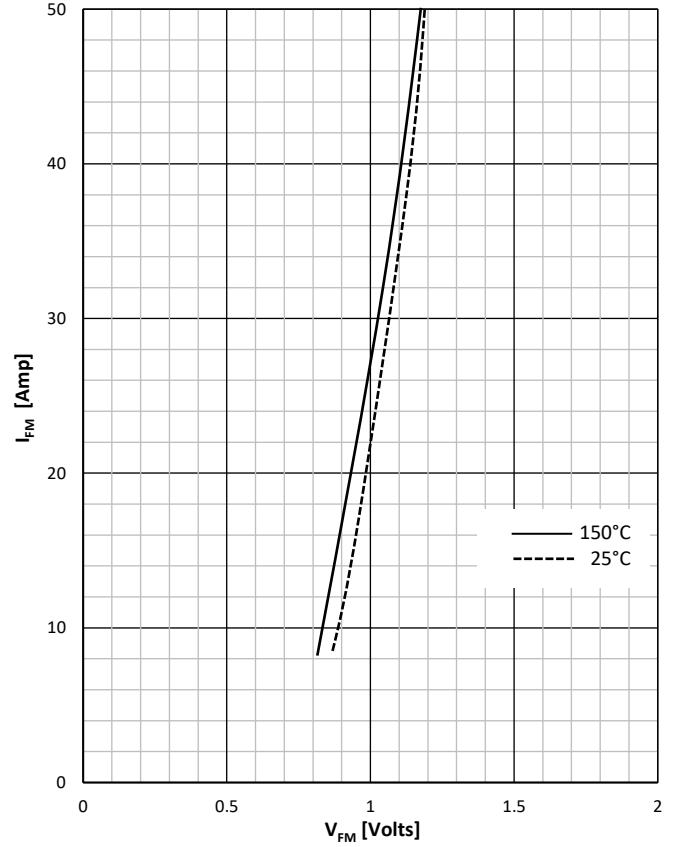

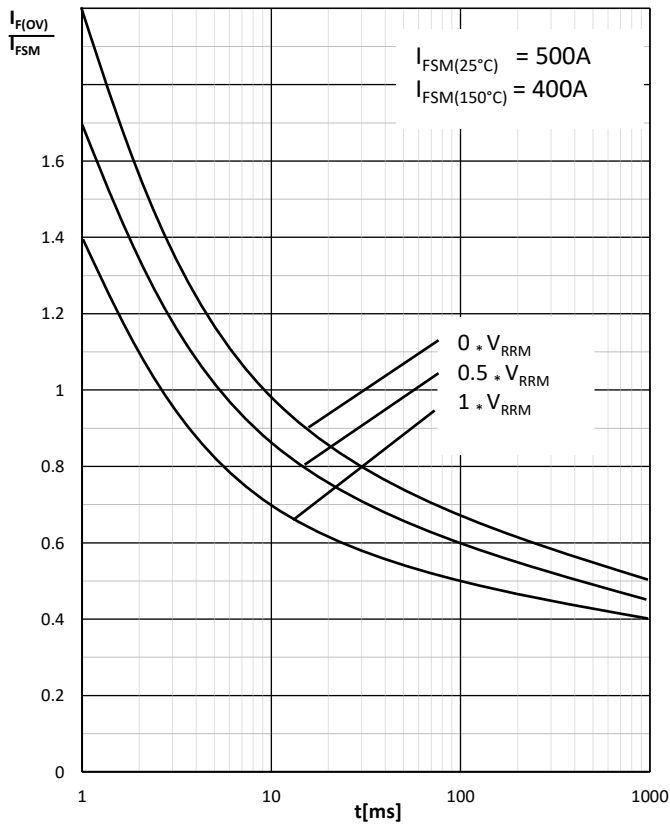
POWER DISSIPATION Vs OUTPUT CURRENT



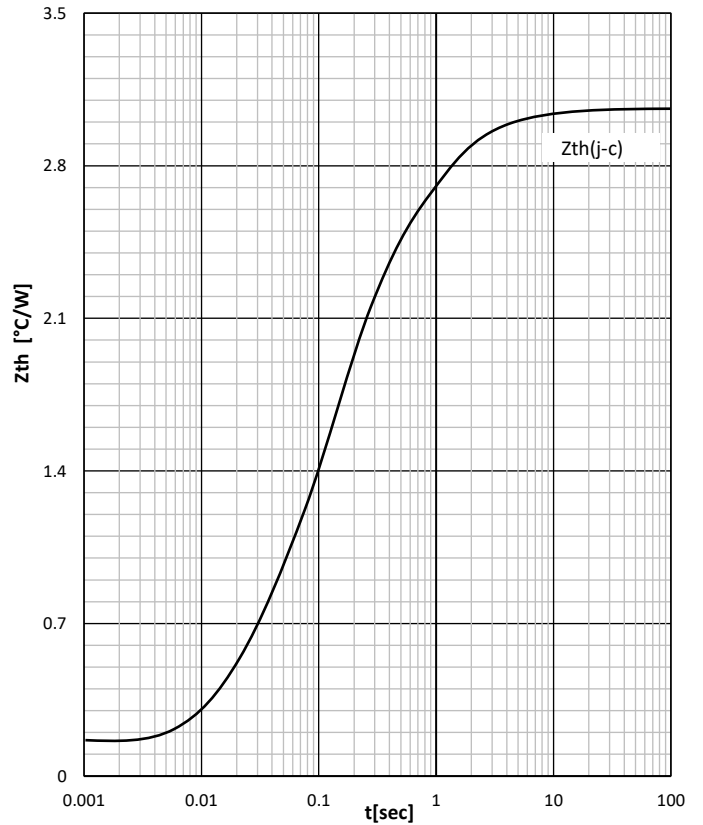
ON -STATE CHARACTERISTIC OF A DIODE ARM



SURGE CHARACTERISTICS

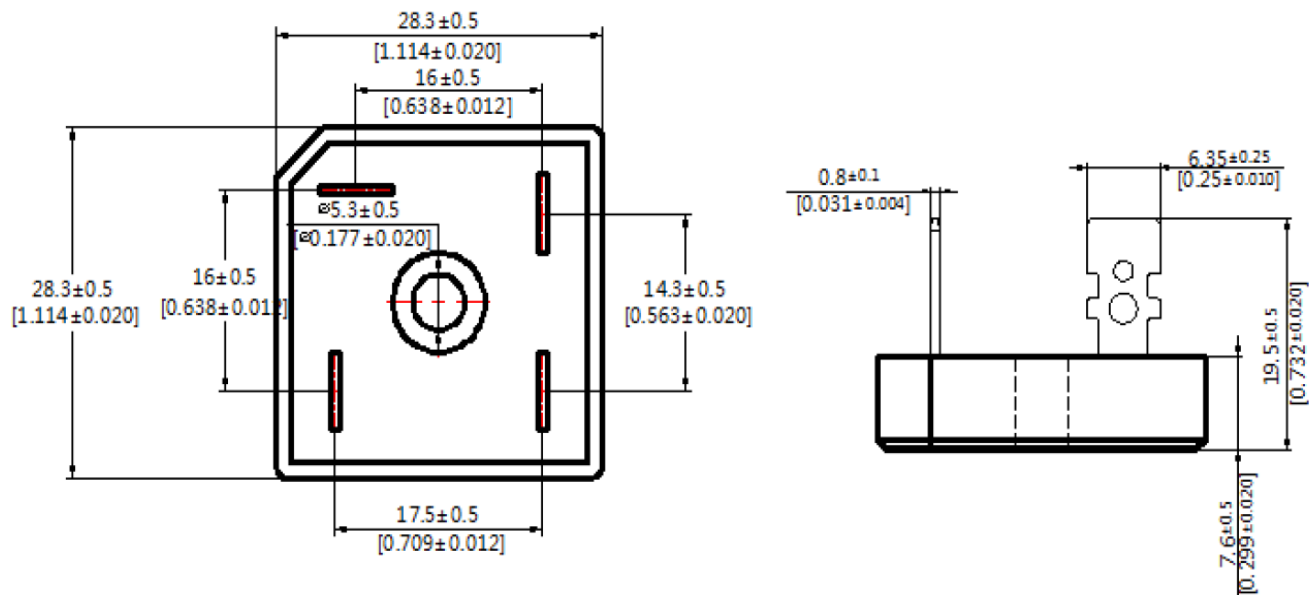


TRANSIENT THERMAL IMPEDANCE, PER ARM
